## New York State Comptroller's Office To Schedule Audit Of Ulster County Resource Recovery Agency

Ulster County Legislature's Chairman Frederick J. Wadnola in a letter dated March 3, 2011, requested that the New York State Office of the Comptroller perform a complete audit of the Ulster County Resource Recovery Agency now or at its earliest convenience. Chairman Wadnola said, "I fully support this request along with the Legislator Kevin Roberts, Chairman of the Governmental Services and Administration Committee and the Ulster County Comptroller Elliott Auerbach."

On April 18, 2011, Chairman Frederick J. Wadnola received a letter from the New York State Office of the Comptroller concerning the Ulster County Resource Recovery Agency. Based on the information provided to the Office of the Comptroller, they plan to initiate an audit of the Ulster County Resource Recovery Agency later this spring.
